Notice of Race (NoR)

Version 2.4 – March 27th, 2024

(Changes from 2.1 are in *Red*)

The Sidney North Saanich Yacht Club will be hosting its 41st Patos Island Race on April 13/14, 2024.

This regatta is a Vancouver Island Racing Series (VIRS) event and results will count towards the 2024 series. No registration is required for this series.

The event is a designated BC Offshore Series event. Separate registration is required for this series. You can register at: <u>BC_LD_Champ</u>.

There will be a long course of 67 nm and a short course of 43 nm. The long course is open to yachts with PHRF BC ratings of 175 or less; the short course is open to all PHRF rated yachts. There will be a double handed division for the Long or Short Course if a four boat minimum is attained.

SNSYC will attempt to provide moorage for participating yachts. Larger/deep draft vessels may need to secure moorage at local marinas.

All social activities are held at SNSYC. The race start is in the vicinity of the Sidney downtown waterfront.

2 RULES

- **2.1** The event is governed by the rules as defined in *The Racing Rules of Sailing*, available at <u>"RRS"</u>. The prescriptions of Sail Canada apply, available at <u>"SC_RRS_Per"</u>.
- 2.2 The Rules of PHRF BC, available at <u>"PHRF BC"</u>. Updated to 2024 rules.
- 2.3 [DP] All monohull boats shall comply with Category 3 of the 2022–2023 World Sailing Offshore Special Regulations for Monohulls with Canadian Prescriptions (available at "OSR_3 mono_Can") as amended by The BC Sailing Keelboat Committee (available at "BCCat3").
- **2.3.1** 5.01.1 d) Spray Hoods, for 2024 only prepend "recommended".
- 2.4 [DP] All multihull boats shall comply with Category 3 of the 2022–2023 World Sailing Offshore Special Regulations for Multihulls with Canadian Prescriptions (available at "OSR_3 multi_Can") as amended by The BC Sailing Keelboat Committee (available at "BCCat3"). Amendment 2.3.1 above applies. The following amendments are for multihulls only:
- **2.4.1** 3.07.3 Escape hatches for multihulls less than 12m, prepend "recommended:".
- **2.4.2** 3.29.2 VHF antenna for multihulls, for 2024 only prepend "recommended:".
- **2.4.3** 3.14 Pulpits, Stanchions, Lifelines, prepend "recommended"
- **2.4.4** Add "3.14.2 b) On a boat with no lifelines the use of a harness tethered to jackstays and/or clipping points (see 4.04) is recommended at all times when not below deck."
- **2.5** The International Regulations for Preventing Collisions at Sea (IRPCAS) shall replace the relevant sections of Part 2 of the RRS between sunset and sunrise. IRPCAS is available at <u>"IRPCAS"</u>.
- **2.6** Race participants will be required to download the Kwindoo Tracking system on their smart phone. This will require each boat to maintain a smart phone with data (including the USA) and a means of keeping the device charged throughout the race duration.
- 2.7 Boats entered as a Double-Handed crew are allowed to use self-steering and/or autopilot mechanisms for sail changes and other situations, where having one crew member assigned to steering the yacht may compromise the safety of crew and craft. This changes RRS 52.

3 SAILING INSTRUCTIONS

3.1 The sailing instructions will be available after 08:00 on April 1st at <u>https://patosislandrace.com/</u>.

5 ELIGIBILITY AND ENTRY

- **5.1** The event is open to all boats with a valid 2024 PHRF BC certificate. 2024 PHRF NW certificates will be accepted and will be normalized to PHRF BC regulations.
- **5.2** Classes are defined as follows:

Long Course	PHRF BC	PHRF ≤ 175
Short Course	PHRF BC	Any handicap

Division splits will be announced at the skippers meeting.

5.3 Eligible boats may enter by registering online at <u>https://patosislandrace.com</u> together with the required fee by 23:59 April 8th, 2024.

There will be no course selection changes allowed by race participants after 11:00 April 9th 2024.

5.4 The number of boats entered is limited to 55. Boats will be placed on a waiting list once there are 55 entries.

6 FEES

6.1 Entry fees are as follows:

7 CREW LIMITATIONS

7.1 As per OSR 6.01.2, At least 30% but not fewer than two crew members, including the Person in Charge, shall have undertaken a one-day Sail Canada accredited (or equivalent) coastal personal survival course within five years before the start of the race. For double handed entries, OSR 6.01.2 requires that at least one shall have undertaken training.

BC Sailing and The Sailing Foundation both offer Safety at Sea programs. At this time,

8 COURSES

- 8.1 The race start is in the vicinity of the Sidney downtown waterfront.
- **8.2** The Racing Area is shown in Appendix A, Course Description. Competitors are strongly advised to check the appropriate charts for navigational hazards.

9 PENALTY SYSTEM

9.1 For boats in the Long and Short Courses, RRS 44.1 will apply (Two-Turns penalty).

10 RISK STATEMENT

10.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.


11 INSURANCE

11.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$1,500,000 Cdn per incident or the equivalent. A hard copy of the insurance policy must be on board while racing.
